#### **INTRODUCTION**

The purpose of this circular is to provide you with details regarding (i) the grant to the Directors of the proposed Issue Mandate; (ii) the grant to the Directors of the proposed Repurchase Mandate and the extension of the Issue Mandate by addition thereto of the number of Shares repurchased pursuant to the Repurchase Mandate; (iii) the proposed re-election of retiring Directors; and (iv) the proposed re-appointment of auditors and to give you the AGM Notice and seek your approval of the resolutions relating to these matters at the AGM.

#### **GENERAL MANDATE TO ISSUE SHARES**

The Company's existing mandate to issue Shares was approved by ordinary resolutions at the annual general meeting held on 8 May 2017. Unless otherwise renewed, the existing mandate to issue Shares will lapse at the conclusion of the AGM. In accordance with Article 16.18 of the Articles of Association, at each annual general meeting of the Company, one-third of the Directors for the time being (or, if their number is not three or a multiple of three, then the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director, including those appointed for a specific term, shall be subject to retirement by rotation at least once every three years. Accordingly, at the AGM, Mr. Sze Yan Ngai and Mr. Iu Tak Meng Teddy will retire from office by rotation and, being eligible, will offer themselves for re-election.

#### 5. UNDERTAKING

From August 2009 to July 2011, he was a member of the Vetting Committee of the Create Smart Initiative which was established by the Hong Kong Government to provide financial support to initiatives that are conductive to the development and promotion of creative industries in Hong Kong. He is also the founding member of Hong Kong Novel Association. Mr. Sze was elected as the "1st Hong Kong Digital Entertainment Industry Person of the Year" by the Hong Kong Digital Entertainment Association in 2007.

As at the Latest Practicable Date, Mr. Sze was deemed interested in 29,012,337 Shares registered in the name of Right One Global Limited and Ms. Sze. Save as disclosed above, as at the Latest Practicable Date, Mr. Sze had no interests (within the meaning of Part XV of the SFO) in any Shares, underlying Shares or debentures of the Company and/or its associated corporations.

Mr. Sze has entered into a director's service agreement with the Company for a term of three years commencing on 13 January 2016 subject to rotation and re-election at annual general meetings of the Company in accordance with the Articles of Association. The director's fee of Mr. Sze is HK\$696,000 per annum which is determined with reference to his experience, duties and responsibilities within the Company.
