### **PROFIT WARNING**

This announcement is made by Gameone Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2) of the Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company and potential investors that according to the unaudited management accounts of the Group for the eight months ended 31 August 2016, the Group had incurred a net loss for that period of approximately HK\$3.0 million. Based on the preliminary review of the said unaudited management accounts and other information currently available, the Group is expected to record a net loss for the nine months ending 30 September 2016 (the “**Period**”), as compared with the net profit recorded for the corresponding period of 2015.

Such anticipated loss is mainly attributable to the lower than anticipated revenue for the Period due to the lower than anticipated revenue contribution from the product launch in the Period in contrast with the significant increase in revenue recorded in the corresponding period last year as a result of the launch of Demi-Gods and Semi-Devils 3D\* (天龍八部3D) in February 2015, which had contributed approximately HK\$41.7 million, representing approximately 43.5% of the total unaudited revenue for the nine months ended 30 September 2015. Furthermore, the Group’s self-developed mobile game The Ravages of Time (mobile version)\* (火鳳燎原手機版) generated approximately HK\$10.3 million in revenue, representing approximately 10.8% of the unaudited revenue for the nine months ended 30 September 2015. Together these two mobile games contributed 56.2% of the Group’s total unaudited revenue for the nine months ended 30 September 2015.

This announcement is made solely on the basis of the preliminary assessment made by the management of the Group with reference to the unaudited management accounts of the Group for the eight months ended 31 August 2016 and information currently available. Such management accounts have not been audited or reviewed by the Company's auditor and are subject to finalisation and adjustments (such as game life review). Further details of the Group's performance will be provided in an announcement of the quarterly results of the Group for the nine months ending 30 September 2016, which is expected to be published in or around mid-November 2016. Shareholders and potential investors are advised to read carefully the said quarterly results announcement of the Company when it is published in accordance with the GEM Listing Rules.
