ENTERING INTO AN EXCLUSIVE LICENSE AGREEMENT
WITH FOX NETWORKS GROUP ASIA PACIFIC LIMITED
FOR “MY DATE WITH A VAMPIRE” TO DEVELOP GAMES
AND PRODUCE AND PUBLISH COMIC**

This announcement is made voluntarily by Gameone Holdings Limited (the “**Company**”). The Company (together with its subsidiaries, the “**Group**”) is pleased to announce that Gameone Group Limited (a wholly-owned subsidiary of the Company, “**Gameone HK**”) has entered into an exclusive license agreement with Fox Networks Group Asia Pacific Limited (“**FNG Asia**”) in January 2019, pursuant to which Gameone HK was granted the exclusive comic adaptation rights and exclusive games development rights of “MY DATE WITH A VAMPIRE” in the People’s Republic of China (the “**PRC**”), Hong Kong, Macau, Taiwan, Singapore and Malaysia by FNG Asia (the “**Exclusive Rights**”). The comic and games are expected to be officially launched in the first quarter of 2020. The Company has recently paid the relevant fees regarding the Exclusive Rights from FNG Asia.

FNG Asia is 21st Century Fox’s multi-media business in Asia Pacific and the Middle East. FNG Asia develops, produces and distributes entertainment, sports, factual and movie channels in 14 languages. The FNG Asia portfolio includes over 30 channel brands, on both linear and non-linear platforms. As the region’s leading broadcaster, FNG Asia has offices in Hong Kong, the PRC, Taiwan, Japan, Korea, Singapore, Malaysia, Indonesia, Philippines, Thailand, Vietnam, India, Australia and the UAE. FNG Asia is a fully owned subsidiary of 21st Century Fox.
